OPEN DAIRY GOAT SHOW

Registration Required

Rules:

1. All animals are at the risk of the owners while on the grounds, and must be cared for by the owners or their employees unless other arrangements have been made in advance with the Goat Show management.
2. No animals are to be tied/penned in the Red and White Show Building.
3. All animals must be on the grounds by noon the day of the show. All animals are to remain on the grounds until 9pm. Animals removed before 9pm will lose premiums. Upon removal of your animals – pens must be cleaned out and pushed to the center of the barn.
4. Stall area will be assigned by the Fair Directors and/or designee – reserving the right to limit number of exhibitor stalls to number of animals to be exhibited. Buildings will not be altered in any way.
5. Initial Bedding will be furnished free of charge- one bale per pen of 2 to 3 animals for pre-entered is guaranteed to each exhibitor, extra bedding is first come, first serve. Bring your own hay and grain. Exhibitors are responsible for cleaning up manure deposited in walkways between their areas, the show ring and the wash rack.
6. All exhibitors must clean out their areas immediately before leaving the grounds by raking debris into the aisle. Failure to do so may result in loss of premiums.
7. Registrations/health papers must be shown to show management, a fair director and/or veterinarian.
8. Entries giving name of animals, breed, registration numbers, and birth dates must be sent to: Tracy Smith 115 Jackson Valley Road, Oxford, NJ 07863. No later than July 6, 2026. Entry Fee \$5.00 per animal. Post Entries will be accepted between July 7, 2026 up until 1:00pm the day of the show. Fee for Post Entry will be \$10.00 per animal.
9. Showmanship is open to the youth 21 years of age or young as of January 1, 2025. Proof of age may be required. Animals must be owned or leased by the exhibitor. And NO POST ENTRIES WILL BE PERMITTED for showmanship classes.
10. For a breed to have its own classes there must be 5 animals entered in the breed with a minimum of 2 exhibitors. Dairy Goats will be judged against all other Dairy Goats –if minimums numbers are not met to have their own breed show in an AOB class. Premiums will be paid as follows: Type Classes only - 1st - \$10, 2nd - \$8, 3rd - \$6, 4th \$5, 5th - \$3.00
11. Ribbons will be awarded for places in all classes.
12. Special Awards will be given to Champions/Reserves and all Special Classes and Showmanship that pre-registration was received in.

5. Champion Junior Doe & Reserve Champion Junior Doe

Junior Bucks:

6. Junior born 5/1/26 to 7/1/26
7. Intermediate born 1/1/26 to 4/30/26
8. Senior born 9/1/25 to 12/31/25
9. Champion Junior Buck & Reserve Champion Jr. Buck

SENIOR DOES:

10. Does 2 Year old and younger in Milk
11. Does 3 to 4 Years Old in Milk
12. Does 5 to 6 Years Old in Milk
13. Does 7 Years old and Older in Milk
14. Dry Does
15. Senior Champion & Reserve Senior Champion Doe
16. Grand Champion & Reserve Grand Champion (Champion and Reserve of all Previous Classes)

SPECIAL CLASSES

17. Dam & Off Spring
18. Produce of Dam (two female animals any age from the same dam)
19. Best Animal Bred and Owned.
20. Best three animals any age with at least one in milk.

SHOWMANSHIP

21. Age 17 to 21 Years Old as of January 1, 2026
22. Age 13 to 16 Years Old as of January 1, 2026
23. Age 9 to 12 Years Old as of January 1, 2026
24. 8 years and Younger as of January 1, 2026

Health

Any exhibitor showing at the Warren County Farmers Fair must be in compliance with New Jersey Division of Animal Health recommendations for New Jersey Fairs, shows and sales. All animals must be free from infectious or contagious disease.

- A. A valid (official) Certificate of Veterinary Inspection (CVI) signed by an accredited New Jersey Veterinarian must accompany all native New Jersey Animals. The CVI must indicate that all animals of the species to be exhibited on the exhibitor's premises have been observed by a veterinarian and found to be free of any signs of infection or contagious disease. The official New Jersey Certificate of Veterinarian Inspection is valid for 30 days in New Jersey. Animals originating from other states must be accompanied by an official Interstate Certificate of Veterinarian Inspection in compliance with New Jersey's import regulations. All domestic animals requiring CVI for exhibition must be individually identified by one of the acceptable species methods and it must be listed on the health certificate. If any additional identification is present, it should also be listed. CVI must be checked by a fair director and/or their designee and/or veterinarian.
- B. All animals which are eligible for an approved USDAA rabies vaccination should be current on rabies vaccinations, and proof of vaccination by a veterinarian should be provided.
- C. All animals must be free of ringworm and pinkeye.
- D. Animals not meeting health regulations will be asked to leave the grounds.
