Registration Required

Rules:

1. All animals are at the risk of the owners while on the grounds, and must be cared for by the owners or their employees unless other arrangements have been made in advance with the Show management.
2. No animals are to be tied/penned in the Red and White Show Building.
3. All animals must be on the grounds by 8AM the day of the show. Animals may come in Friday July 24th after 4 pm and before 8pm- which we suggest due to Horse events and parking Saturday morning
4. All ANIMALS MUST remain on the grounds until 9:00 PM the evening of the show. Upon removal of your animals – pens must be cleaned out and pushed to the center of the barn. LEAVING PRIOR TO DISMISSAL WILL RESULT IN FOFETURE OF PREMIUMS.
5. Stall area will be assigned by the Fair Directors and/or designee – reserving the right to limit number of exhibitor stalls to number of animals to be exhibited. Buildings and Penning will not be altered in any way.
6. Initial Bedding will be furnished for pre-entered exhibitor, extra bedding is first come, first serve. Bring your own hay and grain and water buckets.
7. Exhibitors are responsible for cleaning up manure deposited in walkways between their areas, the show ring and the wash rack.
8. Registrations/health papers must be shown to show management, a fair director and/or veterinarian.
9. Completed Entry forms with all information completed on the form must be sent to: Tracy Smith 115 Jackson Valley Road, Oxford, NJ 07863. No later than July 6, 2026. Post entries will be accepted with additional the fees after July 6, 2026. Post entry registration ends Saturday July 25th at 8am.
10. Entry Fee: Breeding Sheep – Open \$10.00, Youth \$5.00, Fleece \$5.00 by July 6th.
After July 6th – Open \$20.00, Youth \$10.00, Fleece \$10.00
Commercial Meat Goats – Youth only Show \$5.00, after July 7th - \$10.00
Market Lamb & Market Goats - \$25.00 Prior to July 6th, \$35.00 after July 6th
POST Entries Close at 8am the day of the show. Insufficient Fund checks will be charged an additional \$40.00.
11. Showmanship is open to the youth 21 years of age or younger as of January 1, 2026. Proof of age may be required. Animals must be owned or leased by the exhibitor. And NO POST ENTRIES WILL BE PERMITTED for showmanship classes.
12. For a breed to have it's own classes there must be 5 animals entered in the breed with a minimum of 2 exhibitor or there must be a breed sponsor. Breed sponsorships are \$150.00
13. Fleece Entry is one entry per exhibitor per breed.
14. Commercial Meat and Commercial Wool will have their own classes.
15. Market Goat and Market Lamb classes are open to wethers and ewes. These animals CAN NOT cross enter into commercial/breed classes.
16. Market Goat and Market Lamb weigh ins will be from 7:00am to 8:30am on Saturday July 25th. Classes will be broken up accordingly and posted.
17. Premiums will be paid as follows:
Open Sheep Breed Classes: \$20.00- First, \$15.00- Second, \$10- Third, \$8- Fourth, \$5 – Fifth Place.
There will be Champion Ram, Ewe & Fleece if wool breed- of Each Breed will get an award and There will be a Supreme Champion Ram, Ewe and Fleece over all.

Youth Sheep Breed & Commercial Goat Classes: \$10- First, \$8- Second, \$6- Third, \$5 – Fourth, \$3- Fifth Place.

Market Goats & Market Lambs: 1st Place -\$30, 2nd Place- \$20

Champion Market Goat & Market Lamb will receive \$50.00

Reserve Champion Market Goat & Market Lamb will receive \$25.00

Animal Health

Any exhibitor showing at the Warren County Farmers Fair must be in compliance with New Jersey Division of Animal Health recommendations for New Jersey Fairs, shows and sales. All animals must be free from infectious or contagious disease.

- A. A valid (official) Certificate of Veterinary Inspection (CVI) signed by an accredited New Jersey Veterinarian must accompany all native New Jersey Animals. The CVI must indicate that all animals of the species to be exhibited on the exhibitor's premises have been observed by a veterinarian and found to be free of any signs of infection or contagious disease. The official New Jersey Certificate of Veterinarian Inspection is valid for 30 days in New Jersey. Animals originating from other states must be accompanied by an official Interstate Certificate of Veterinarian Inspection in compliance with New Jersey's import regulations. All domestic animals requiring CVI for exhibition must be individually identified by one of the acceptable species methods and it must be listed on the health certificate. If any additional identification is present, it should also be listed. CVI must be checked by a fair director and/or their designee and/or veterinarian.
- B. All animals which are eligible for an approved USDAA rabies vaccination should be current on rabies vaccinations, and proof of vaccination by a veterinarian should be provided.
- C. All animals must be free of ringworm and pinkeye.
- D. Animals not meeting health regulations will be asked to leave the grounds.
