July 25 – August 1, 2026

Please take a moment to review these instructions. Many of your questions will be answered below. We are looking forward to another enjoyable and successful Fair season.

1. **FAIR HOURS:** 3:00pm – 10:00pm during the weekdays and 12:00pm to 10:00pm during the weekends. Vendors need to be opened or items on display during the hours of the fair.
2. **LOCATION:** Return a completed contract with at least a 50% deposit to reserve a space at the fair. Personal checks are not accepted after July 1st. You will need to pay by money order, cash or credit card after this date. There is a 4% surcharge for credit card payments. Spaces are reserved on a first come, first serve basis. Spaces are not permitted to be subcontracted. All fees are non-refundable. You will receive a confirmation letter with your spot location in June.
3. **TENTS:** If you are supplying your own tent, make sure that it fits in the space you have requested. (i.e. If you have a tent that takes up 11 feet you will need to rent a 15-foot space). Please remember that you may have a vendor directly next to you. Your display needs to be set-up at least **3 feet back** from the walkway – including overhangs. You will be asked to move if you do not conform to this request. If you are renting a tent from us, please add on an additional 10 feet of space to allow for stakes and ropes.
4. **INSURANCE:** You must send a Certificate of Insurance OR a completed Insurance Request Form (to be on our user policy) which is enclosed to Strategic Insurance Partners, PO Box 2507, Flemington, NJ 08822. If sending a certificate, please be sure you conform to the following rules:
 - Send the certificate to Strategic Insurance Partners by mail, e-mail shazard@siprisk.com or fax to 908-788-9371.
 - Specify the certificate holder and additional insured to be: Warren County Farmers' Fair Association, Inc., 1350 Strykers Rd, Phillipsburg, NJ 08865
 - Be sure the effective dates cover the period of the Fair.
 - Do not send a copy of your policy, application or binder. Only a Certificate of Insurance with a current date is acceptable.For additional information, please see paragraph #1 of Terms and Conditions of Contract (enclosed). If you do not provide a Certificate of Insurance or the Insurance Request Form prior to July 15th, you will not be admitted to the Fair and your contract will be voided. Please contact Strategic Insurance Partners if you have special circumstances. All fees are NON-REFUNDABLE. **If you have any questions in regards to the insurance stipulations, please call Strategic Insurance Partners directly at 908-788-9080.**
5. **PASSES:** Complimentary passes for entry into the fair will either be mailed with your confirmation letter or given to you when you arrive for set-up. Additional one-day passes may be purchased at ½ price for our vendors at \$5.00 each. If you do not have a pass, you will be charged full admission price into the Fair. You can also exchange your “all week” passes for “one day” passes. Each “all week” pass is equivalent to 8 “one days”. This needs to be done by July 15th. We also have season passes available to our vendors at a discounted price of \$20.00 each. Each pass allows one person into the fair. Please make sure the people working your booth are supplied passes or they will be charged at the gate. **Lists given at the gates will not be permitted. They must have a pass.**
6. **ITEMS NOT ALLOWED:** Exploding devices, smoke bombs, bag bombs, knives of any kind, blow darts, weapons or items that cause litter or odor on the fairgrounds are not permitted. The sale of CBD and related products are not permitted.
7. **ELECTRICITY:** One 110V – 24 amp electrical outlet is included per vendor. There will be a charge of \$75.00 for each additional outlet used. You will need to supply your own extension cord and lights if needed. Electricity to the fairgrounds will be turned off on August 15th. You are responsible for removing all items from the fairgrounds by that time.
8. **VEHICLES:** Please be advised that cars are not permitted on the fairgrounds during fair hours. If you plan on leaving your vehicle on the fairgrounds, it must be on the spot that is assigned to you. You will have to pay an additional fee if you do not abide by this.

TERMS AND CONDITIONS OF CONTRACT

1. The concessionaire, at his own cost and expense, shall procure and maintain insurance as follows: (1) Workers Compensation Insurance coverage for statutory coverage as required. (2) General Liability Insurance for Bodily Injury, Property Damage, and Personal Injury Liability with a limit of no less than \$1,000,000 per occurrence and with a General Aggregate of no less than \$2,000,000. Warren County Farmers' Fair Association, Inc., 1350 Strykers Road Phillipsburg, NJ 08865 shall be named as Additional Insured and Certificate Holder for ongoing and completed operations, on a primary and non-contributory basis. A waiver of subrogation in favor of the Warren County Farmer's Fair Association, Inc. shall be included on the General Liability insurance policy. A certificate of insurance showing evidence of this coverage must be submitted prior to arrival for set-up at the fairgrounds. The certificate must show evidence of additional insured status, primary and non-contributory coverage for the additional insured, and a waiver of subrogation. Note: Insurance Certificates shall be received prior to July 15th, 2026. Certificates are to be either e-mailed – shazard@siprisk.com; faxed directly to our insurance consultants (908-788-9371) or mailed to Strategic Insurance Partners, PO Box 2507, Flemington, NJ 08822. Telephone 908-788-9080. Please do not make our insurance agent the certificate holder. It should be Warren County Farmers' Fair Association, Inc., 1350 Strykers Road, Phillipsburg, NJ 08865.
2. The concessionaire shall defend, indemnify, and hold harmless the Warren County Farmers' Fair Association, Inc., its Directors, Employees, Agents, and Volunteers against all loss, cost, and damages on account of injury to persons or property occurring in the performance of this agreement, together with all attorney's fees incurred by the Warren County Farmers' Fair, its Directors, Employees, Agents, and Volunteers, or upon their account. The concessionaire waives all rights of recovery against the Warren County Farmers' Fair Association, Inc. for all property or casualty losses. The concessionaire further waives any claim against the Warren County Farmers' Fair, Inc. arising from a communicable disease of any nature including but not limited to the virus severe acute respiratory syndrome coronavirus 2 (SARS-Co-V-2), which is responsible for Coronavirus Disease (COVID-19), and/or any mutation or variation thereof.
3. Concessionaires and exhibitors must keep their locations in a neat and sanitary condition. Personnel shall be neat and presentable. The Warren County Farmers' Fair, its Directors and employees, has the right to have removed any offensive literature or articles. Concession stands provided by the concessionaire must be neat and professional in appearance, (not of "makeshift" variety). The Warren County Farmers' Fair, its Directors and employees reserve the right of approval.
4. No advertising signs other than those pertaining to the particular concession for which space is used shall be displayed on any stand or booth and signs thus permitted shall be placed so as not to interfere or obstruct the view to or from other booths. Signs are not to be placed on the walkway and only put on the space itself that you are renting. No public address systems permitted.
5. All requests for space must be made on forms furnished by the Warren County Farmers' Fair, its Directors and employees. The right to reject any and all requests is reserved. If the Warren County Farmers' Fair, its Directors and employees cancels its Fair or Exhibit or does not sponsor a Fair or Exhibit for any reason whatsoever, the money paid on this contract shall be returned and the Warren County Farmers' Fair, its Directors and employees shall not be obligated to sponsor any Fair or Exhibit, nor shall it be liable to the exhibitors or concessionaires in any manner whatsoever.
6. All buildings to be occupied and fixtures of any types attached to such buildings, are the sole property of the Warren County Farmers' Fair, its Directors and employees, and any improvements and/or additions made by the concessionaire to the building and/or fixtures, may not be removed upon the expiration of the agreement, but shall become the sole property of the Warren County Farmers' Fair, its Directors and employees.

7. The concessionaire and its successors shall not assign or underlet this agreement or any part thereof or make any alterations to the buildings and/or fixtures without the Warren County Farmers' Fair, its Directors and employee's written consent.
8. The payment of any and all sales tax imposed by Federal, State and/or local governments upon the operation of the concession, and the keeping of the records therefore, shall be the sole responsibility of the concessionaire.
9. There shall be no gambling nor holding lotteries of any type by the concessionaire, and in the event the concessionaire deviates from this regulation, then the concessionaire shall indemnify and hold harmless the Warren County Farmers' Fair, it's Directors and employees for any and all damaged incurred by the Warren County Farmers' Fair, it's Directors and employees by reason of such deviation.
10. The Warren County Farmers' Fair, it's Directors and employees shall have no liability whatsoever for any loss resulting to the concessionaire, directly and indirectly, from strikes, labor disturbances, fire, defaults of supplies, repairs made by the Warren County Farmers' Fair, it's Directors and employees and its agents on the premises, weather, and other uncontrollable events, and there shall be no rebate or refund of the rental fee herein because of such loss.
11. Failure of either party to exercise any right contained herein shall not be construed as a waiver of the exercise of such right by either party at some subsequent date.
12. No dogs shall be allowed at large on the grounds. You must clean up after your dog on all public areas of the fairgrounds.
